

## **Important Information Regarding Section 9-305 of the Philadelphia Code of Ordinances Governing Burglary, Theft and Robbery Alarm Systems**

Bill # 080856 was enacted by City Council on December 4, 2008 and was signed by the Mayor on December 8, 2008. This ordinance is effective immediately.

The ordinance makes the following changes to the alarm system law:

- The annual registration fee is now \$50
- The number of free false alarms each registration year is now two (2); any false alarms over two (2) is considered excessive and constitutes a violation of the Philadelphia Code
- The initial charge for each excessive false alarm is now \$75
- Penalties for non-payment of the initial \$75 charge for each excessive false alarm are now
  - 1<sup>st</sup> Penalty \$25
  - 2<sup>nd</sup> Penalty \$50
- Failure to register or failure to pay annual registration charges can result in fines of \$150 to \$300 per alarm activation for the use of an unregistered alarm system
- Disputes and hearing requests regarding these charges should be sent to Department of Finance, PO Box 56318, Philadelphia, PA 19130-0318.
- Hearings will be held at the Office of Administrative Review at the Land Title Building, 100 S. Broad St, 4<sup>th</sup> Floor, Philadelphia, PA.
- Failure to answer or appear shall be considered an admission of liability
- Other civil action may result from the failure to pay the amount due

OCCUPANT OR USER. THE FEE COVERS ONE YEAR WHICH BEGINS  
ON THE 1ST DAY OF THE MONTH (AND YEAR) IN WHICH THE ALARM  
SYSTEM IS INSTALLED OR IN WHICH AN ACTIVATION IS REPORTED  
TO THE PHILADELPHIA POLICE. THE USE OF AN UNREGISTERED  
ALARM SYSTEM COULD RESULT IN A FINE OF \$150-\$300 PER  
ACTIVATION.
